In compliance with Section 58 Paragraph 2 of the Act No. 111/1998 Coll., on Higher Education Institutions and on Amendments of and Supplements to Other Acts (Higher Education Act), as amended, the Ministry of Education, Youth and Sports of the Czech Republic declared on January 30, 2019 the base for setting the fees related to study for the academic year 2019/2020 at the amount of **CZK 4, 090** (in words four thousand and ninety Czech crowns).

According to this base and in compliance with the internal regulation Provision on Fees Related to Study at the University of Chemistry and Technology, Prague and Article 23 of the internal regulation "Statute of the University of Chemistry and Technology, Prague", the amounts of fees related to study are for the academic year 2019/2020 as follows:

In the academic year 2019/2020, a student studying in a bachelor or master study programme for more than the standard term of study increased by one year shall pay for the term of the first twelve months a fee equal to four times the base, i.e. the amount of CZK 16,360 rounded up to CZK 16,400 (in words sixteen thousand four hundred Czech crowns) for each commenced six months of study; in the following years the student shall pay eight times the base, i.e. the amount of CZK 32,720 rounded up to CZK 32,800 (in words thirty-two thousand eight hundred Czech crowns) for each commenced six months of study.

A student studying in a study programme provided in a foreign language shall pay a fee under Section 58 Paragraph 4 of the Higher Education Act. In compliance with Article 23 of the internal regulation "Statue of the University of Chemistry and Technology, Prague", the amount of the fee for study in a study programme in a foreign language for the academic year 2019/2020 shall be sixteen times the base, i.e. CZK 65,440 rounded up to **CZK 65,500** (in words sixty-five thousand five hundred Czech crowns).

Waiver, reduction, deferment or division in several payments of fees related to study.

Within the process of deciding on revision of the decision regarding charging a fee related to study, the Rector may waive, reduce, defer or divide the payment of the above stated fees, taking into account award of study results or social scholarship, extremely difficult study, social, health or family situation of the student and extraordinary professional or social representation of UCT Prague.

The Rector decides on the waiver, reduction or deferment of the fee based on the student's written appeal raised within 30 days of notification of the Dean's decision to charge the fee related to study; the appeal shall contain an attachment containing documents providing reasons for the appeal.

Further information, if necessary, shall be provided by the Department of Education.
