- 1. This Decree is issued based on the Order of the Prague Hygiene Station, ref. no. S-HSHMP 04297/2020 (hereinafter referred to as the "Order") (hereinafter referred to as "HSHMP"), which prescribes extraordinary measures in case of danger of an epidemic outbreak. HSHMP is the authority with the material competence and territorial responsibility pursuant to Act. No. 258/2000 Coll., on Protection of Public Health and amendment to some related acts.
- 2. The Decree applies to students and employees at UCT Prague and regulates extraordinary measures in case of danger of an epidemic outbreak upon return from the area of contagion the People's Republic of China (hereinafter referred to as the "PRC").
- 3. - 4. Employees or students who are aware of the fact or learn that a person visiting UCT Prague arrived in the given period from the PRC, will report this fact using electronic communication at zahranici@vscht.cz. At the same time, employees and students are obliged to inform the visiting person about the content of this Decree.
- 5. Pursuant to the Order, the Department of International Relations is thereby required to immediately inform HSHMP in writing and by phone about the arrival of students or teachers and other individuals from the PRC that are reported to them in accordance with Articles 3 and 4 hereof.
- 6. Employees and students who arrived from the PRC are forbidden to participate in lessons at UCT Prague, in particular to enter areas designated for instruction and study at UCT Prague, libraries and restaurants at UCT Prague or work at departments at UCT Prague for the duration of 2 weeks (incubation period) upon their arrival from the PRC.
- 7. Senior workers will allow their direct subordinates to work from home after they have reported the facts in accordance with Article 3 hereof for the number of working days required to complete the period of quarantine, i.e. 2 weeks upon their arrival from the PRC.
- 8. We strongly recommend that everyone should get acquainted with the <u>recommendation</u> issued by the Ministry of Health to citizens in connection with the spread of Chinese coronavirus 2019-nCov.
